PARKING LOCAL LAW - LOCAL LAW NO. ONE (1) of 1987
TOWN OF WORCESTER

SECTION 1 PROHIBITION OF ALL NIGHT PARKING. No vehicles shall be parked on any of the following public streets in the Hamlet of Worcester, County of Otsego, New York, between the hours of 2 A.M. and 6 A.M. during the period beginning November 1st and ending May 1st of each year; MAIN STREET FROM DECATUR STREET east as far as COOK STREET.

SECTION 2 PARALLEL PARKING. No vehicle shall be parked on Main Street in the Hamlet of Worcester, Town of Worcester (Route 7) other than parallel with the edge of the street, headed in the direction of traffic, with the front and rear wheels not more than six inches from the curb.

SECTION 3 PROHIBITION OF PARKING IN DESIGNATED LOCATION. The parking or standing of vehicles in any of the following locations in the Hamlets of Worcester and East Worcester, Town of Worcester, Otsego County, New York, is hereby prohibited:

- (a) on the west side of ELM STREET
- (b) on the east side of COOK STREET
- (c) on the west side of DECATUR STREET from ROUTE #7 and to the Niagara Mohawk Substation
- on the east side from the intersection of FAIRLAWN AVENUE to the Niagara Mohawk Substation
- (d) on the west side of CHASE STREET to No. 12 Chase Street
- (e) on the south side of MAPLE STREETS
- (f) on the east side of NORTH CHURCH STREET between points 25 feet north and 25 feet south of the driveway entrance of the WORCESTER FIRE DISTRICT FIRE HOUSE; and on the opposite and west side of said NORTH CHURCH STREET 60 feet opposite from the fire house
- (g) on either side of STATE HIGHWAY 7 between CHURCH STREET and WATER STREET
- (h) within 30 feet from the edge of STATE HIGHWAY 7 on all side streets intersecting said STATE HIGHWAY 7
- (i) on the south side of STATE HIGHWAY 7 directly in front of the EAST WORCESTER FIRE HOUSE

- (j) on either side of NORTH ROAD (County Route #38) starting at STATE HIGHWAY 7 north to the intersection of ALGERINE HILL ROAD
- (k) on either side of WEST HILL ROAD from STATE HIGHWAY 7 to HALLECK DRIVE

SECTION 4 STOP STREETS. Main Street in the Hamlets of Worcester and East Worcester, Town of Worcester, Otsego County, New York, is hereby designated as a main artery of travel, and all vehicles approaching said main artery of travel from any and all side streets shall before entering the main artery, come to a full stop, unless otherwise directed by a peace officer or signal.

SECTION 5 SIDEWALKS.

- (a) all parking is prohibited on any and all sidewalks and designated sidewalk areas in the TOWN OF WORCESTER.

SECTION 6 ONE WAY STREET. DECATUR STREET in the Hamlet of Worcester, New York shall be and is hereby designated as a one way street, and all vehicles on such street are to proceed in a northerly direction only.

SECTION 7 REPEAL OF PRIOR ORDINANCES AND LOCAL LAWS. All ordinances and local laws or parts of ordinances or local laws of the Town of Worcester inconsistent with the provisions of this parking local law are hereby repealed; provided, however, that such repeal shall only be to the extent of such inconsistency and in all other respects this parking local law shall be in addition to the other ordinances and local laws regulating and governing the subject matter covered by this ordinance and local law.

SECTION 8 PENALTY FOR VIOLATIONS. Any persons violating any of the provisions of these SECTIONS above enumerated of this parking local law shall be punishable for the first offense by the fine not to exceed ten dollars (\$10.00), and for the second offense by a fine of not less than ten dollars (\$10.00) or more than twenty-five dollars (\$25.00) or by imprisonment for not less than two (2) nor more than fifteen (15) days. The third or any subsequent offense within one year shall be punishable by a fine not exceeding one hundred dollars (\$100.00) or by imprisonment not to exceed six months or by both such fine and imprisonment.
